# **PROGRAM UPDATES**

### **EDUCATION JUSTICE**

The CCC seeks a new member of its team to lead our Education Justice Program. The program promotes policies and practices that improve educational outcomes for children of color in Multnomah County and across Oregon. Focus areas include, but are not limited to, improving early learning opportunities, eliminating disproportionate discipline, improving outcomes for English Language Learning students, supporting culturally-specific parent and family engagement, and ensuring culturally-responsive pedagogy and school culture. ### LEADERSHIP DEVELOPMENT

The Coalition of Communities of Color's Leadership Development Initiative is driven by the

CCC's values of honoring culturally-specificity while simultaneously building a multicultural movement for collective action. The Initiative's mission is to expand the capacity of communities of color to self-organize, network, build culturally-specific social capital, and develop our own pathways to greater social inclusion and equity.

Over 300 leaders of color have already participated in the 6 culturally-specific leadership programs housed under the Initiative, and are led by CCC member organizations: Africa House, Asian Family Center, APANO, PAALF, NAYA, Latino Network and the Slavic Network.



On February 21, 2015, all of the culturally-specific programs came together for the first time to share an intensive day of cultural sharing, transformative conversations and community building. Many thanks to Luna Jiménez Seminars for leading the day and the generous support of Meyer Memorial Trust to make the event possible.

Moving forward, the Initiative will be an integral part of our communication program, which is scheduled to be implemented over this quarter. In addition to our programmatic updates in the Equity Lens, the Initiative will feature its own quarterly newsletter, the Leaders Bridge, which will focus on creating a bridge of communication between each of the culturally-specific leadership development programs as well as their participants and alumni. The first edition of the Leaders Bridge will be released in May 2015 and will serve

as a comprehensive resource for opportunities in the following areas:

- Leadership
- Employment
- Civic Engagement
- Mentorship

### **ENVIRONMENTAL JUSTICE**

The CCC has officially launched its Environmental Justice Program that will build on long held priorities and work in Oregon's communities of color. The Environmental Justice Program responds to the urgent need to engage Oregon's growing, diverse communities in the decisions made around protecting our environment; build our advocacy and leadership capacity in communities of color on climate solutions; and to create a culturally-specific approach and lens within the broader environmental justice movement.



The Environmental Justice Program's focus is to increase capacity in communities of color around environmental justice and climate resiliency; centralize the voices of communities most impacted by environmental injustice and climate change; reform policy practices; and review strategies to produce environmental, economic, and social benefits in communities of color.

CCC Members have already initiated community dialogues to identify environmental priorities and needs that are reflective of their respective community. The CCC and its members are currently providing leadership and voice in Oregon's conversation about pricing carbon as well as developing a CCC climate resiliency platform.
